Memorandum of Understanding Between Virginia Commonwealth University School of Nursing and Southside Virginia Community College

The Virginia Commonwealth University School of Nursing (VCU SON) and Southside Virginia Community College (SVCC) recognize the need to facilitate completion of the baccalaureate degree among graduates of associate degree programs. VCU Health Community Memorial Hospital (CMH) in South Hill, Virginia, is a primary employer of SVCC graduates. There is a high degree of interest in increasing the number of baccalaureate-prepared nurses who may seek employment at CMH. This agreement provides an accelerated and streamlined baccalaureate of sciences degree (BS) completion pathway at VCU SON for students enrolled in SVCC through a collaborative concurrent enrollment plan. The goals for this agreement are to 1) reduce time to complete BS degree, and 2) increase number of BS graduates, 3) increase the pool of BS-prepared nurses available for employment by CMH. Specifically, participants will be able to begin the RN-BS program while continuing to prepare for the NCLEX exam.

The overarching intent of this collaboration is for SVCC students to 1) receive early advisement regarding VCU SON BS program completion requirements; 2) complete required prerequisite course work at SVCC; 3) co-enroll in the VCU SON RN-BS program and complete 6 credits of RN-BS courses during the last year of enrollment at SVCC; and 4) continue RN-BS courses at the SON following graduation from SVCC in a dedicated cohort at VCU. VCU may appoint qualified faculty from SVCC to teach RN-BS program courses to SVCC students as adjunct VCU SON faculty under applicable VCU affiliate faculty policies.

Section I: Eligibility

To be guaranteed admission to the VCU SON under this collaboration, SVCC students must:

- Complete a minimum of 41 credit hours of VCU SON RN-BS prerequisite and general education courses (see Table 1) prior to the beginning of the fall semester of the final year in the SVCC program.
- 2. Earn a minimum cumulative college-level grade point average of 2.5 on a 4.0 scale;
- 3. Earn a minimum grade of "B" in all the required SVCC nursing classes in their first year of nursing courses at SVCC;
- 4. Earn a minimum grade of "C" in the required prerequisite and general education courses as noted in Table 1.
- 5. Apply to the VCU School of Nursing by the posted application deadline (see: https://nursing.vcu.edu/admission/application-instructions/rn-to-bs/).

Section II: Academic Terms of Co-Enrollment

- Upon receipt by VCU of completed application materials demonstrating eligibility, SVCC students are guaranteed admission to VCU SON RN-BS program for the fall term of the student's last year of enrollment in SVCC's nursing program.
- Students will be co-enrolled in SVCC and VCU SON for the fall and spring terms of the student's last year of enrollment in the SVCC nursing program. Students will complete the following VCU RN-BS courses:
 - Fall term: NURS 301 Informatics (3 credits, online)
 - Spring term: NURS 307 Foundations of Professional Nursing I (3 credits, online)
- 3. SVCC students will be charged VCU tuition and fees for these two courses.

Section III: Academic Terms of Continuing Enrollment

- 1. Students must earn a minimum grade of "B" in all the remaining SVCC nursing classes taken during their final year at SVCC.
- 2. Students must maintain a minimum cumulative college-level grade point average of 2.5 on a 4.0 scale at SVCC.
- 3. Any remaining prerequisite or general education courses required for the RN-BS program and taken at SVCC must be completed with a grade of "C" or better.

- 4. An earned grade less than a "C"/satisfactory may be repeated once. If the repeated course or another course is failed with a grade less than a "C"/satisfactory, the student may not proceed in the nursing major and is dismissed from the VCU School of Nursing.
- 5. Student must satisfy all SVCC continuous enrollment policies.
- 6. Upon completion of the Associate of Applied Science (AAS) degree, students will be required to pass the NCLEX examination and obtain a VA nursing license not later than the beginning of the fall semester of their continuing enrollment at VCU. Failure to obtain a VA nursing licensure by the designated timeline will result in disenrollment from the program. Students will be eligible for readmission to the RN-BS program once the license has been obtained and verified by the dedicated RN to BS advisor for VCU SON.
- If degree completion date at SVCC is delayed, interrupted or discontinued, the student may not be able to continue in the VCU RN-BS program and/or subject to readmit policies for the RN-BS nursing program.
- 8. The VCU RN-BS curriculum requires 32 credits in the nursing degree to be earned at VCU; thirty (30) of the last 45 credits must be earned at VCU.
- All outstanding prerequisite coursework must be satisfied prior to enrolling in the NURS 488 course.

Section IV: Transfer of Credits

- 1. After successful completion of NURS 308 at VCU, VCU will award students up to 39 proficiency credits from their AAS degree (based on an assessment of their prior learning and clinical work experience).
- Under applicable academic policy, VCU will award qualifying credit for college courses applicable to the AAS degree taken through dual enrollment arrangements with high schools as regular proficiency credits.
- 3. Course credit awarded through Advanced Placement, Cambridge, CLEP, DANTES, International Baccalaureate, and Armed Services experience will be accepted according to stated policies for acceptance of credit, which can be found in the VCU

Undergraduate Bulletin for the year the SVCC student enters VCU. To seek credit from VCU, students must submit the necessary transcripts or documentation of this additional coursework to VCU no later than the conclusion of their first semester of coenrollment at VCU.

Section V: Responsibilities

SVCC agrees to do the following:

- 1. Notify students of the collaboration opportunity with VCU under this agreement
- Provide academic advising services to assist SVCC students in selecting required courses for admission to the RN-BS program. Further, SVCC will prepare faculty advisors and counselors to provide appropriate and accurate advising services related to students' plans to apply to VCU.
- Notify the Chief Transfer Officer at VCU
 (http://www.schev.edu/AdminFaculty/VCTOcontact.asp) when situations arise warranting SVCC and VCU faculty interaction to address advising or curricular issues.

There are no intended third party beneficiaries to this agreement. SVCC agrees to inform prospective and participating students that they are responsible for the following:

- 1. Understanding the requirements for the BS in Nursing at VCU.
- Meeting with VCU academic advisors to discuss transferability of courses and advice for a successful transition from SVCC to VCU.
- Following the VCU application processes and deadlines
 (http://nursing.vcu.edu/admission/application-instructions/rn-to-bs/) and providing official transcripts from any other institutions attended and documentation for Advanced Placement, International Baccalaureate, Cambridge, CLEP, military credit, or other advanced standing credit applied toward completion of the transfer-oriented associate degree.

VCU agrees to do the following:

- 1. Disseminate accurate information to prospective students regarding the general conditions of this collaborative agreement.
- Provide academic advising services through the VCU Transfer Center and School of Nursing to SVCC students during the term prior to transfer to assist these students in making a smooth transition from the community college to VCU. VCU advisors will assist students in registering for NUR 301 and NUR 307.
- Notify the Chief Transfer Officer (http://www.schev.edu/index/agency-info/advisory-committees/virginia's-chief-transfer-officers) at SVCC when situations arise that warrant SVCC and VCU faculty interaction to address advising or curricular issues.
- 4. If sufficient enrollment (a minimum of 15 students) and faculty capacity (as determined by VCU) is met, students will be offered placement in a special section of course work with their SVCC cohort. The cohort will proceed through the VCU RN-BS curriculum 6 credits each semester, summer, fall, spring continuously until graduation (see Table 2). Students must successfully complete all courses in the designated sequence to remain in

- this cohort. If there is insufficient enrollment for an SVCC cohort, or if a student has to repeat a course, students may be placed in regular, non-cohort course sections.
- 5. Provide tracking data on performance of SVCC students at VCU, including credits presented and accepted in transfer, VCU courses attempted and completed, cumulative GPA, major, graduation date from VCU, and comparisons with native students. The specific data elements and the timing of the report will be determined by Institutional Research staff from SVCC and VCU.

Section V: Review of the Agreement

- 1. SVCC will designate officials who will be responsible for all aspects of this agreement and VCU will designate individuals responsible for all aspects of this agreement at VCU.
 - a. Representing VCU will be the Vice President for Health Sciences and VCU Health System Chief Executive Officer and the Dean of the School of Nursing and the Provost and Vice President for Academic Affairs, or designees.
 - Representing the SVCC will be Dr. Tara Blackwell, VP for Academic and Student Affairs and the Dean of Nursing, Allied Health, and Natural Sciences, or designees.
- 2. Both parties will communicate the conditions of the agreement to their respective clientele (external and internal constituents). VCU and the SVCC will review the agreement at a minimum of every three years and make adjustments or amendments as deemed appropriate to maintain the integrity of each institution as well as for the improvement of the transfer process and student articulation. Such changes will not adversely affect students already enrolled and covered under the provisions of the existing agreement.
- 3. This agreement shall be effective upon execution by both parties and shall remain in effect for an initial period of three (3) years. This agreement may be renewed for set terms of one to three years thereafter upon written agreement of the parties. Either party may terminate this agreement upon 60 days written notice to the other party. Any student(s) co-enrolled at VCU at the time of notice of termination shall be given the opportunity to complete the RN-BS degree in alignment with degree-completion requirements.
